

# MEDINA COUNTY BIG TREE CONTEST

## Contest Guidelines:

- 1.) The 2018 contest is open for the tree Pin Oak (*Quercus palustris*).
- 2.) Tree nominated must be located in Medina County.
- 3.) A tree may be nominated only once. The first nomination received will be entered in the contest.
- 4.) The tree does not have to be on the property of the nominator, however, permission of the landowner must be obtained by the nominator.
- 5.) The Medina County nomination form must be submitted to:

- 6.) All nomination forms must be received by July 27, 2018 - 4:30 p.m.
- 7.) All nominated trees will be measured by qualified personnel who will use the official Ohio's Big Tree nomination form. Decisions of the judges will be final.
- 8.) The Medina Big Tree Award will be presented at the Annual Banquet of the Soil and Water Conservation District to be held in the fall.

# Big Tree Contest

The Medina County Soil & Water Conservation District (SWCD) and the Medina County Gazette will sponsor the Sixteenth Annual Big Tree Contest. In this contest, entrants submit a nomination for a predetermined type of tree they believe might be the largest in the county. Qualified personnel will measure the trees to determine the winner.

The contest procedures are based on requirements of the Ohio Division of Forestry, since winners may be submitted for the Ohio Big Tree Program as a state champion. You may not have a state champion, but the tree could be Medina County's champ.

- ❖ 2018 trees will be the **Pin Oak** (*Quercus palustris*).
- ❖ The tree nominated must be located in Medina County.
- ❖ A tree may be nominated only once. The first nomination received will be entered in the contest.
- ❖ The tree does not have to be on the property of the nominator; however, permission of the landowner must be obtained prior to nomination.
- ❖ The nomination form must be submitted to the SWCD office by July 27, 2018.
- ❖ Qualified District personnel will measure all nominated trees. The decision of the District will be final.
- ❖ Prizes will be awarded at the District's annual meeting in the fall.
- ❖ Prizes will include a \$25.00 coupon to be used for the District's 2019 tree seedling sale (no other cash value) and a plaque with tree's statistics.
